Owner is Santa Nella County Water District. Sealed pre-qualification packages are due on or before 3:00 P.M., Wednesday, December 13, 2023, at the Santa Nella County Water District office, located at 12931 State Highway 33, Santa Nella, CA 95322. The project area is located in Santa Nella, CA and Volta, CA, and includes work within Henry Miller Road. The work to be performed under this Contract consists of water quality improvements to the existing District water system, including improvements at the existing District distribution site to add pumps and storage to blend treated surface water and groundwater from the existing Well No. 1 and production Well No. 2, drilled in July 2023 as the first phase of this Project. The project includes construction of a water transmission pipeline from the Well No. 2 site located near the community of Volta that includes bore and jack crossings at the (Central California Irrigation District (CCID) Main and Outside Canal and across Henry Miller Road near the Well No. 1 site. The District has obtained license agreements with CCID for the infrastructure improvements at the Main and Outside Canal crossings. The project also includes improvements to consolidate the existing Volta community. The consolidation includes supplying existing Volta customers with water from Well No. 2. Water meters will be installed on existing residential and commercial service laterals. The existing Volta well will be destroyed and associated well site facilities will be removed as part of this Project. The Project consists of furnishing and installing any and all transportation, materials, equipment, tools, excavation, utilities, sheeting, shoring, bracing and supports, plant and other facilities, and all management, superintendence, permits, labor and services in accordance with the Contract Documents therefore adopted and on file with the District. The District will obtain right of entry agreements, as needed, for work completed on private property.

The Contractor shall hold an active contractor's license in the A classification. A mandatory pre-qualification meeting will be held at the District Office, 12931 S Highway 33, Santa Nella, CA 95322, on Wednesday, December 6, 2023 at 1:00 P.M. It is the responsibility of the Contractor to check the website for any addendum to the project.
